## Section 3 - Composition/Information on Ingredients

**Product Description:** Ready to use oil based insecticide for controlling various home garden insect pests. Milky liquid with minimal odour.

## Section 4 - First Aid Measures

**Inhalation:** Remove victim from area of exposure - avoid becoming a casualty. Seek medical advice if effects persist.

**Skin Contact:** If skin contact occurs, remove contaminated clothing and wash skin with soap and water. If irritation occurs, seek medical advice.

**Eye Contact:** If in eyes, wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

**Medical attention and special treatment:** Treat symptomatically.

## Section 5 - Fire Fighting Measures

**Hazards from combustion products:** Non-combustible material.



**Precautions for fire fighters and special protective equipment:** Not combustible, however following evaporation of the water component of the material, the residual material can burn if ignited. Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

**Suitable Extinguishing Media:** Not combustible, however, if material is involved in a fire use: Water fog (or if unavailable fine water spray), foam, dry agent (carbon dioxide, dry chemical powder).

## Section 6 - Accidental Release Measures

**Methods and materials for containment and clean up:** Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers. If contamination of sewers or waterways has occurred advise local emergency services.

## Section 7 - Handling and Storage

**Conditions for safe storage:** Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Keep containers closed when not in use - check regularly for leaks.

**Precautions for safe handling:** Keep out of reach of children. Avoid skin and eye contact.

## Section 8 - Exposure Controls and Personal Protection

**Occupational Exposure Limits:** No value assigned for this specific material by the National Occupational Health and Safety Commission. However, Exposure Standard(s) for constituent(s):

Oil mist, refined mineral: 8hr TWA = 5 mg/m<sup>3</sup>

As published by the National Occupational Health and Safety Commission.

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

### Engineering controls:

Natural ventilation should be adequate under normal use conditions.

### Personal Protective Equipment:

Avoid contact with eyes and skin. Do not inhale spray mist. Wash hands after use. Always wash hands before smoking, eating, drinking or using the toilet.
