## Section 3 - Composition/Information on Ingredients

**Product Description:** Oil based insecticide for control of scale, aphids, mealy bugs and mites on citrus, other fruit trees and roses. Pale yellow liquid.

## Section 4 - First Aid Measures

## Section 6 - Accidental Release Measures

**Methods and materials for containment and clean up:** Wear protective equipment to prevent skin and eye contact. Slippery when spilt. Avoid accidents, clean up immediately. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers. **Conditions for safe storage:** Store in the closed, original container in a dry, cool, well-ventilated area out of direct sunlight. Keep containers closed when not in use - check regularly for leaks.
